When Greg Brockbank talks about **MAJOR ISSUES** facing San Rafael, **HE DOESN'T EVEN MENTION PUBLIC SAFETY** in debates or on his website, except to say, that *"... reforms and cuts adopted by the City Council have enabled us to continue to provide the public safety and other services our residents have come to expect."*

"I would love to be able to afford to increase staffing (as well as pay and provide benefits in order to attract the best possible candidates) to improve public safety. But those times may be at least some years off until the larger economy improves."
 Brockbank treats public safety like it's just another city department – when he puts residents, businesses owners and first responders **IN HARM'S WAY**. When asked about restoring 2009 police staffing levels, Brockbank said **HE FELT BADLY ABOUT IT.**

"I would love to have continued to have 104 positions & would particularly like to restore at least SOME of the last ones... I imagine the PD would not want to have to suffer the ill will of the majority of the public if they saw YOUR department protected while others were dismantled."

SAN RAFAEL RANKS 315 OUT OF 461 COMMUNITIES FOR VIOLENT CRIME PLACING IT IN THE BOTTOM THIRD FOR PUBLIC SAFETY IN CALIFORNIA.



San Rafael has 4.23 violent crimes per 1,000 population, which is **SLIGHTLY** better than the state average of 4.41, but ranks us **LOWEST IN MARIN**. Belvedere ranked #1 in California while San Rafael ranked #315—two cities in the same county, so close yet so far apart.
