

AN ORDINANCE OF THE CITY OF SAN RAFAEL AMENDING ORDINANCE NO. 1583  
TO ADJUST THE COMPENSATION FOR CITY COUNCIL

THE CITY COUNCIL OF THE CITY OF SAN RAFAEL DOES ORDAIN AS FOLLOWS:

DIVISION 1. Section 36516(a) of the California Government Code (amended in 1984, effective in 1985) provides that the compensation of Councilmembers in a City the size of San Rafael may be set at \$400 per month by Ordinance. Section 36516(c) further provides that compensation of Councilmembers may be increased beyond the amount provided by an amendment to an Ordinance but the amount of the increase may not exceed an amount equal to 5 percent for each calendar year from the operative date of the last adjustment of the salary in effect when the Ordinance was enacted. Section 36516.1 of the California Government Code provides that an elected Mayor may receive additional compensation above that provided to Councilmembers. Ordinance No. 1541 authorized a salary adjustment for the Mayor and Council effective January 1, 1988 in the amount of \$649 per month for Mayor and \$433 per month for each Councilmember. Ordinance No. 1583, adopted December 18, 1989, would have amended Ordinance No. 1541 by increasing the salaries for Mayor and Council to a total of 8% or 4% per year, effective January 1, 1990, except that due to a clerical error, Ordinance No. 1583 incorrectly increased the salaries of Mayor and Council to a total of 10% or 5% per year.

DIVISION 2. As of January 1, 1990, the Mayor shall receive \$702 per month and each Councilmember shall receive \$468 per month. This compensation shall be paid in the same manner as paid to other officers and employees of the City of San Rafael. This is an 8% increase, at 4% per year.

DIVISION 3. This Ordinance shall be published once in full before its final passage in a newspaper of general circulation, published and circulated in the City of San Rafael, and shall be in full force and effect thirty (30) days after its final passage.
